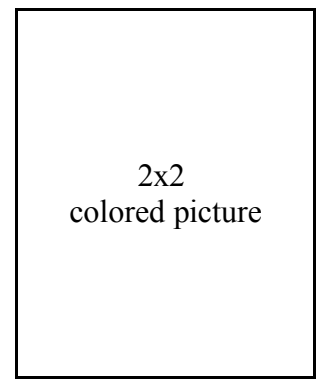

- f) Written and sworn declaration that the investment shall be within the Clark Special Economic Zone;
- g) Certificate of allocation issued by the President of the Investor firm/entity that it has allocated US\$250,000.00 or its equivalent in other foreign currency to a foreign national, assigned to render service to the said investor within the Zone;
- i) Certificate of Registration issued by CDC
- j) Permit to Operate issued by CDC
- k) Application and Visa processing fees

Requirements for dependents accompanying the SCWV applicant

- a) Birth and/or Marriage Certificates for dependents and/or spouse;
- b) NBI Clearance for dependents who are 18 yrs old and above;

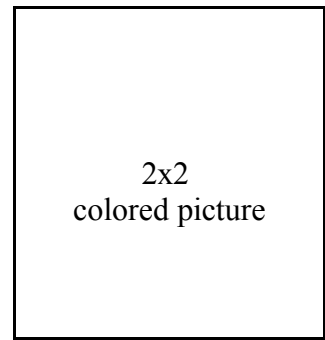
